**IV. PUBLIC COMMENT:**

**Tazewell County Clerk John Ackerman regarding historical markers -**

Tazewell County Clerk John Ackerman came before the Board to explain the historical marker that Tazewell County will be placing in Mackinaw marking the first courthouse in Tazewell County as part of their bicentennial anniversary. Ackerman stated that with America 250<sup>th</sup> coming up it would be a good time for the Village to add an Abe Lincoln site to the state's historical markers. President Schmidgall and the Board agreed to work on adding historical markers within the Village, especially since 2027 the Village will be having our bicentennial celebration. The Village will contact Ackerman to assist with submitting a historical marker with the state marking a place that Abe Lincoln was in Mackinaw.

**V. DEPARTMENT REPORTS:**

**1. PUBLIC WORKS MANAGER'S REPORT:** Public Works Manager Mike Schopp reported on the activities of the department. Schopp reported on a water main leak at Heritage Lake that was repaired. Street sweeper has been out 3 times. Lost a tree at Veterans Park near the playground. The trees behind the playground are dead and Schopp is thinking of installing a fence where the trees are located. The department has been working on vehicle maintenance and repairs for public works and police. The rock from the alley along the IGA collects on Monroe Street when a hard fast rain happens. Schopp is looking at tar and chip for that alley to keep this from happening.

**Award Water Main Project –** Trustee Severt moved, seconded by Trustee Wilkins to grant the water main project on Second St. and White St. to Twin Lake Civil Construction. On a roll call, the vote was:
