October 14, 2024

Mayor Schmidgall called the meeting to order at 7:00 p.m. This was a regular meeting of the Village of Mackinaw.

V. DEPARTMENT REPORTS:

POLICE CHIEF'S REPORT: Police Chief Mike Kemp reported on the activities of the department.

PUBLIC WORKS MANAGER'S REPORT: Public Works Manager Mike Schopp reported on the activities of the department.

Mill and pave alley behind firehouse – The Board reviewed the proposal from Tazewell County Asphalt Company Inc. to mill and pave the alley behind the firehouse.

Trustee Haynes moved, seconded by Trustee Morman to waive the formal bidding and accept the proposal from Tazewell County Asphalt Company Inc. to mill deteriorated asphalt and install 4" of asphalt to the alley behind the firehouse at a cost of \$18,160.00. On a roll call, the vote was:

Pave industrial park entrances – The Board reviewed the proposal from Tazewell County Asphalt Company Inc. to install asphalt approaches to the businesses in the industrial park. The funds for this project would come from business district tax funds.

Trustee Morman moved, seconded by Trustee Severt to waive the formal bill proposal and accept the proposal from Tazewell County Asphalt Company Inc. to install asphalt approaches to the businesses in the industrial park at a cost not to exceed \$64,800.00. The funds for the project will come from business district tax funds. On a roll call, the vote was:

Asphalt walkway at Brock Lake - The Board reviewed the proposal from Tazewell County Asphalt Company Inc. to asphalt the walkway between diamonds at Brock Lake. Mackinaw Recreation will be voting on doing a portion of the asphalt for this project and Tazewell County Asphalt Company Inc. will be donating a portion of the project.

Trustee Peterson moved, seconded by Trustee Kamp to waive formal bidding and accept the proposal from Tazewell County Asphalt Company Inc. to asphalt the walkway between diamonds at Brock Lake at a cost for the Village of \$20,000. On a roll call, the vote was:
