1. **POLICE CHIEF'S REPORT:** The Board reviewed the report showing the activities of the department.

Swearing in Officer Stieghorst – Chief Kemp swore in newly hired Officer Blaze Stieghorst. Stieghorst was introduced to the Board and given congratulations on joining the Mackinaw Police Department.

2. PUBLIC WORKS MANAGER'S REPORT: Public Works Manager Mike Schopp reported on the activities of the department. The department flushed fire hydrants in the Village and Heritage Lake. Schopp stated that Mackinaw collected over 180 tires for Tazewell County Tire Drive. Maintenance was done on the pump at the trailer park lift station. The department replaced a fire hydrant at 300 W Fourth Street.

Remove tree at 503 E Madison St. – Schopp updated the Board that his department will be removing the tree in the right a way of 503 E Madison St. due numerous complaints regarding dropping excessive debris on the sidewalk.

Purchase and install two aeration units at sewer lagoon – Trustee Morman moved, seconded by Trustee Wilkins to authorize the purchase and installation of 2 aeration units at the sewer lagoon. On a roll call, the vote was:
