## November 13, 2023

Mayor Schmidgall called the meeting to order at 7:00 p.m.

III. CONSENT AGENDA: The consent agenda consists of approving the October 23, 2023 regular meeting minutes, police department report, EMA department report, Public Works department report, non-recurring disbursements, investment report and payroll report.

## V. DEPARTMENT REPORTS:

POLICE CHIEF'S REPORT: The Police Chief Mike Kemp reported on the activities of the department. Kemp and Schmidgall met with a sales representative for the flock cameras with regards to recent incentives advertised. As a result of the meeting the Village received a discount on the cameras of $\$ 1,950$.

PUBLIC WORKS MANAGER'S REPORT: The Public Works Manager Mike Schopp reported on the activities of the department. Water loss for October was $24 \%$, this is due to hydrant flushing in the Village and at Heritage Lake. The low hanging tree branches in the school bus routes were trimmed. Schopp stated that he will begin looking for a new truck for the department. He would like a bucket truck to assist with hanging and maintenance of hero banners, flags, Christmas decorations and trees.

Resurface downtown alley due to storm drain replacement - Trustee Morman moved, seconded by Trustee Kamp to authorize Tazewell County Asphalt to replace the asphalt in the downtown alley that was removed due to a storm sewer repair at a cost of $\$ 8,700$. The funds for the project will come from downtown business district tax funds. On a roll call, the vote was:

Ordinance \#1050 supplemental appropriation to amend the budget and appropriation ordinance \#1044 - Trustee Peterson moved, seconded by Trustee Severt to adopt ordinance \#1050 a supplemental ordinance to amend ordinance \#1044 making budgets and appropriations for the corporate purposes of the Village of Mackinaw for fiscal year 2024. The ordinance includes increases to the appropriations with regards school crossing guard purposes and IMRF purposes. On a roll call, the vote was:

Documents will be prepared for a $5.6 \%$ increase. On a roll call, the vote was:
