Webster St., Mackinaw, IL to permit any yard, court, buffer strip, setback line or spacing between buildings of less dimension than required by the applicable regulation as stated in §153.055(B) of the Village code. No public attended. The board discussed the placement of the front deck and how no other houses on the block where it is located having a setback that matches what they are requesting. At a rough measurement the distance would be 21' instead of 25'.
