# V. DEPARTMENT REPORTS:

1. **POLICE CHIEF'S REPORT:** The Board reviewed the repost showing the activities of the department.

Amend skateboard ordinance to include that e-scooters and e-bikes are prohibited in public areas bounded by Fast Ave, Main St, Madison St, and Orchard St – This item was tabled.

2. PUBLIC WORKS MANAGER'S REPORT: Public Works Manager Mike Schopp reported on the activities of the department. Honor Wash is done power washing the water tower. The department has been serving vehicles. Curbs will be poured at Monroe St and Madison St this week.

**Purchase of John Deer Mini Excavator** – Trustee Morman moved, seconded by Trustee Cotton to authorize the purchase of a John Deer Mini Excavator from Cross Implement at a cost of \$56,303.63. Funds will come from heavy equipment funds. On a roll call, the vote was:

Request for sewer extension at 31367 Fast Ave – Property owner of 31367 Fast Ave is requesting a sewer extension of a lateral line for a building a home on the property. This can be done by having an easement with an adjacent property owner to the main. The estimated cost would not exceed \$22,000 but would most likely be less due to public works doing part of the work. The Board discussed the return in revenue by sewer bills and property taxes. It was the consensus to pay half of the cost up to \$11,000 and the property owner pay the rest.

Trustee Severt moved, seconded by Trustee Haynes to approve Attorney Pat McGrath to draft an agreement for the Village to pay half of the cost up to \$11,000 of installing a lateral sewer line from the main on Park Trail Rd to 31367 Fast Ave if the home is constructed as stated. On a roll call, the vote was:
