Ordinance No. 813

The **VILLAGE OF MACKINAW**, Illinois, pursuant to Illinois Compiled Statutes Chapter 65, Section 5/3.1-30-21 ordains to adopt hiring standards for part-time police officers.

**BE IT ORDAINED** by the President and the Village Board of Trustees of the Village of Mackinaw, Tazewell County, Illinois, as follows:

**WHEREAS**, the State of Illinois has enacted a revision to the Illinois Municipal Code requiring that municipalities employing part-time police officers shall, by ordinance, establish hiring standards for part-time police officers and shall submit those standards to the Illinois Law Enforcement Training Standards Board; and

**WHEREAS**, the Village Board of Trustees of the Village of Mackinaw, Tazewell County, Illinois, wish to maintain compliance with the Illinois statutory mandate as aforesaid;

**NOW, THEREFORE, BE IT ORDAINED** by the President and Village Board of Trustees of the Village of Mackinaw, Tazewell County, Illinois, as follows:

1. That all police officers, other than those officers who shall be employed on a full-time basis, shall be qualified to enter and successfully complete any training mandated by the Illinois Law Enforcement Training Standards Board;
2. That the aforesaid hiring standard, particularly with respect to part-time police officers employed by the Village of Mackinaw, Tazewell County, Illinois, shall be submitted to the Illinois Law Enforcement Training Standards Board, as required by Illinois Statutes.

**CERTIFICATE OF ORDINANCE**

I, the undersigned, do hereby certify that I am the duly appointed, qualified and acting Village Clerk of the Village of Mackinaw, Tazewell County, Illinois (the "Issuer"), and as such official I am the keeper of the records and files of its President and Board of Trustees (the "Corporate Authorities").

I do further certify the foregoing constitutes a full, true and complete excerpt from the proceedings of the regular meeting of the Corporate Authorities held on the 24<sup>th</sup> day of August, 2010, insofar as same relates to the adoption of Ordinance No. 813, entitled:

**"An Ordinance of the Village of Mackinaw, Tazewell County, Illinois, adopting hiring standards for part-time police officers"**

A true, correct and complete copy of which ordinance (the "Preliminary Ordinance" or "ordinance") as adopted at such meeting appears in the transcript of the minutes of such meeting. The Preliminary Ordinance was adopted and approved by the vote and on the date therein set forth.

I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have complied with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of Ordinance No.813, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on August 24, 2010 and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by six members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.
