CERTIFICATE OF ORDINANCE

I, the undersigned, do hereby certify that I am the duly appointed, qualified and acting Village Clerk of the Village of Mackinaw, Tazewell County, Illinois (the "Issuer"), and as such official I am the keeper of the records and files of its President and Board of Trustees (the "Corporate Authorities").

I do further certify the foregoing constitutes a full, true and complete excerpt from the proceedings of the regular meeting of the Corporate Authorities held on the *14th day of AUG, 2012*, insofar as same relates to the adoption of *Ordinance No. 851*, entitled:

AN ORDINANCE ENACTING AND ADOPTING SUPPLEMENTS TO THE VILLAGE CODE OF THE VILLAGE OF MACKINAW.

A true, correct and complete copy of which ordinance (the "Preliminary Ordinance" or "Ordinance") as adopted at such meeting appears in the transcript of the minutes of such meeting. The Preliminary Ordinance was adopted and approved by the vote and on the date therein set forth.

I do further certify the deliberations of the Corporate Authorities on the adoption of such Preliminary Ordinance were taken openly and was on the agenda at least 48 hours before the meeting at which it was adopted, that the adoption of such ordinance was duly moved and seconded, that the vote on the adoption of such ordinance was taken openly and was preceded by a public recital of the nature of the matter being considered and such other information as would inform the public of the business being conducted, that such meeting was held at a specified time and place convenient to the public, that notice of such meeting was duly given to all of the news media requesting such notice, that such meeting was called and held in strict compliance with the provisions of the Open Meetings Act of the State of Illinois, as amended, and the Illinois Municipal Code, as amended, and that the Corporate Authorities have complied with all of the applicable provisions of such Act and such Code and their procedural rules in the adoption of such ordinance.

The pamphlet form of *Ordinance No.851*, including the ordinance and a cover sheet thereof, was prepared and a copy of such Ordinance was posted for public inspection in the municipal building, the Mackinaw United States Post Office, and the Mackinaw Library commencing on *AUG 24, 2012* and continuing for at least ten days thereafter. The original ordinance was adopted by the Board of Trustees of the Village of Mackinaw at a regular meeting, attended by six members of the Board, and approved by the President, as said Ordinance appears on file in my office and as the same is recorded in the Book of Ordinances of said Village.

ORDINANCE NO. 851

AN ORDINANCE ENACTING AND ADOPTING SUPPLEMENTS TO THE VILLAGE CODE OF THE VILLAGE OF MACKINAW

WHEREAS, the Village of Mackinaw previously purchased from American Legal Publishing of Cincinnati, Ohio a basic village code that the Village of Mackinaw modified and changed;

WHEREAS, the Village of Mackinaw adopted the Village of Mackinaw , after adopting a Village Code on November 14, 1994, through Ordinance No. 513, has made various changes to the Village Code;

WHEREAS, the Village of Mackinaw furnished to American Legal Publishing a copy of all ordinances amending the Village Code of the Village of Mackinaw and requested that American Legal Publishing amend the Village Code based upon the ordinances adopted by the Village of Mackinaw;

WHEREAS, when American Legal Publishing prepared amendments to the Village Code based upon ordinances adopted by the Village of Mackinaw it made other changes to the Village Code it felt were advisable due to changes in Illinois law;

WHEREAS, the Village of Mackinaw was not notified that American Legal Publishing was making additional changes to the Village Code beyond those made by ordinances adopted by the Village of Mackinaw;

WHEREAS, it is the intent of the Village of Mackinaw to accept all changes made by American Legal Publishing since the Village Code of the Village of Mackinaw was adopted.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW AS FOLLOWS:

SECTION 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2: That all amendments to the Village Code of the Village of Mackinaw that have been made by American Legal Publishing prior to the date of this Ordinance are hereby adopted and approved by the Board of Trustees of the Village of Mackinaw. All changes made to the Village Code of the Village of Mackinaw by American Legal Publishing are hereby approved, ratified, and confirmed.


SECTION 3: The village code of the Village of Mackinaw as it exists on the date of this Ordinance shall be the Village Code of the Village of Mackinaw subject to all amendments that are made to the code after the effective date of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 5: Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.

PASSED in due form on a roll call vote by the Board of Trustees of the Village of Mackinaw at a duly held meeting on the 13th day of August, 2012.
