## V. DEPARTMENT REPORTS:

POLICE CHIEF'S REPORT: The Police Chief Mike Kemp reported on the activities of the department.

Purchase of Flock Cameras - Chief Kemp reviewed a quote from Flock Group Inc for the installation and cost of 5 flock cameras to be installed at the entrances to the Village. The cameras read license plates and send instant alerts to law enforcement officers when the cameras identify license plates that match those on lists of cars that are stolen or otherwise of interest to the police.

Trustee Severt moved, seconded by Trustee Morman to authorize the purchase of 5 flock cameras from Flock Group Inc to be installed at the entrances of the Village. The cost for 5 cameras and professional services with include installation, training, and maintenance is a cost of $\$ 20,750$. Annual renewal would be $\$ 3,000$ per camera. PUBLIC WORKS MANAGER'S REPORT: The Public Works Manager Mike Schopp reported on the activities of the department. The motor for the street sweeper has been taken in for repair. The bathrooms are almost complete. There is still some concrete work to be done. Once everything is complete, they will be open to the public. The Ameren pole next to the bathrooms will have bollards placed around and parking will be reassigned to keep the pole from getting in the way of vehicles.

Schopp showed the Board items from recent leaks repaired by the department. One showed that a tree root completely wrapped itself around the pipe and caused a leak. Another showed how copper pipes had been worn through by rocks. This year's drought has most likely played a role in the recent leaks found in the system.

Schmidgall would like the Board to consider a reimbursement amount and program guidelines. The camera footage would be available for the police to use if an issue occurred. The item was tabled until the next meeting.
